1. Tumbewa Rural Municipality, Panchthar invites sealed quotations from registered Fabricator for the Procurement Of Fabrication Package (Fabricated Steel Parts for Trail Bridge) through Sealed Quotation
2. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
3. Eligible Fabricator may obtain further information and inspect the Sealed quotation forms at the PPMO website www.bolpatra.gov.np.
4. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP i.e www.bopatра.gov.np/egp. 5. Sealed bids must be submitted through e-GP system i.e www.bopatра.gov.np/egp on or before 09-04-2023 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 09-04-2023 13:00 at the office of Tumbewa Rural Municipality, Panchthar, Koshi Province, Nepal. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 40000, which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.07400094CA, Account Name: Ga 3.1 Dhaurati Khata, Tumbewa Rural Municipality at Prime Bank Ltd., Tumbewa 3, Panchthar and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
