5. Sealed or electronic bids must be submitted to the office Tumbewa Rural Municipality, office of the rural Municipal Executive, Panchthar province no.1. Nepal by hand/courier or through PPMO website www.bolpatra.gov.np/egpat 12 pm on 3rd May 2019, Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 3:00 pm on 3rd May 2019 at the office of Tumbewa Rural Municipality, office of the rural Municipal Executive, Panchthar, province no.1. Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of 3,00,000/- which shall be valid for 30 days beyond the validity period of the bid .
